

• Browse the current issue - It's easy to read the current issue online. Click the journal cover (1) or the 'Current issue' link (2).


- Searching There are two ways to search a BMJ journal website; the quick search box (3), the 'Advanced Search' link on the homepage (4) or 'Search' on bmj.com for more complex searching (5). All methods search the current issue and
- the archive.
- Linked references You benefit from free access to the full text of cited articles from any of the journals (900+) hosted by HighWire Press
- Online First You can read articles online before they are published in print. Click on the Online First icon (6) or Online first link at bmj.com (7).
- Email Alerts You can receive a variety of email alerts. To sign
 up, click on the 'New content alerts' link (8) or 'Email alerts'
 on bmj.com (9). This is a free service but you'll have to register
 first
- Archive All BMJ journals websites have an archive of previous issues. Every article over 12 months is FREE. Use the 'Browse by Issue' (10) or 'Past issues' (11) links to see the archive.
- Submission and review Our submission and review process is entirely online. Click on the 'Online Submissions' button (12), 'Submit a manuscript' (13) or 'Submission and review' (14).
 For author information, click on 'Author/Reviewer guidelines' (15) or 'Instructions for Authors' (16).
- Personalisation 'My Folders' (17) allows you to save interesting articles and searches into your personal folders.

Article formats – Articles are available as abstracts, extracts, full text, HTML or PDFs. Abstracts and extracts are available to nonsubscribers (18).


- Browse by topic Every article in the BMJ journals is assigned to topic areas, making it easy to search across more than one journal.
- Track topics, papers or authors Sign up for our CiteTrack service and we'll let you know by email whenever new content in your chosen journal is published (19).
- RSS Feeds Receive automatic updates every time the website is updated by our RSS feeds.
- Submit a response Use the 'Submit a response' link to send your comments on any article published in a BMJ journal and, if suitable, they will be published on the site within 48 hours (20).
- PowerPoint Slides Images in full text articles can be downloaded as PowerPoint slides for teaching purposes.
- Future content Websites list recently accepted papers and the table of contents for the next issue as soon as it is available, often up to 6 weeks before the issue is published.
- Email a friend Recommend an article to a friend using this free feature, available on any abstract, full text or PDF (21).
- Feedback To give us your feedback on the site or if you have any general queries, click the 'Feedback' button at the top of any page.
- PubMed Search 12 million bibliographical citations and author abstracts from nearly 5,000 biomedical journals.
- Citation manager Author harvesting of references (22).
- Citation map See a visual representation of the articles citing or cited by your selected article.
- Data supplements Free additional material online that doesn't appear in the print journal. Look out for additional tables, references, videos, images etc.
