Almost all KPI achieved the target or near to target, except;

KPI-PG-1-Students' Evaluation of quality of learning experience in the program achieved average 4.3 on 5 point scale against the targeted value 4.5

KPI-PG-2-Students' evaluation of the quality of the courses achieved 4.35 against targeted value 4.5

KPI-PG-9- Percentage of publications of faculty members Percentage of faculty members participating in the program with at least one research publication during the year to total faculty members in the program, achieved average 90% against the targeted value 100%.

All KPI are compared with Last year attainment (Internal Reference), attainment level is better than previous Yr (2022-23), except;

KPI-PG-3 Students' evaluation of the quality of academic supervision 88% against 100%, Action plan will prepare so, satisfaction level will improve.
