# What is the main purpose for this course?

This course aims to develop the students' ability to plan, analyze, design, implement, validate, and maintain computerized information systems using software processes. Specifically, the course will: Develop the students' skills of selecting a suitable process model (for better project management and better quality software) for a





specific software project, introduce frameworks and quality standards for software development and management, highlight and integrate new process models for new environments, and introduce software metrics for better quality management.

The purpose of this course is to help students to:

- understand information systems and their uses,
- use computerized management information systems,
- do in-depth analysis and decision making,
- apply modern project management techniques,
- be aware security issues related to information systems, and
- enable students to be efficient in their work.
