## Introduction

One of the problems that universities face is the inconsistency and integration of study, and their cumulative succession in terms of knowledge, enabling students to have the different thinking and knowledge and the necessary process from creation, creativity, deduction, good decision-making. From here, the need arises to review the study plans and review the foundations and standards that were built and designed on their basis, the levels of change in them, and how to adopt them through approved stages and approved by the University Agency for Educational Affairs through the administration of study programs.
